



Club Membership Conditions

1. Parents and children acknowledge that soccer training and games is a contact sport and accordingly parents and children hold the Club harmless against all claims of whatsoever nature arising out of any injury, loss or damage suffered as a result of any player participating in any authorised Club soccer training or game.
2. Although players are covered by the FFA National Insurance Programme whilst playing or training, the Club will not be liable for any cost not covered by the FFA insurance, that shall be for the account of the players.
3. The Club strongly recommends that your children be covered by your own private health insurance.
4. Members are required to cooperate and facilitate with the Committee of Management and Staff of the Doncaster Rovers Soccer Club Inc. by assisting on both practice and match days in accordance with a "Roster System" devised by the Team Manager. All members shall be assigned specific tasks by their respective Team Manager based upon a rotating schedule
5. Adults working with children on behalf of Rovers agree to provide the club a copy of their Working With Children Check (WWC). Parents/Guardians of members under 18 must have at least one party with a WWC able to take on the duty roster.
6. Members agree to support the Committee of Management in maintaining and sustaining the facilities provided by the Doncaster Rovers Soccer Club Inc. through volunteering their time in addition to team roles such as at the canteen, working bees, club functions or roles on the Club organisational structure.
7. Members agree to pay all fees promptly within the terms advised annually unless otherwise agreed upon by the Doncaster Rovers Soccer Club Committee of Management.
8. No Pay – No Play - Failing to pay by the due date will result in the player not being able to train or play matches, furthermore FV registrations will not be approved until membership fees are paid in full.
9. An Administration Fee of \$200 will apply for any WRITTEN refund request prior to team selection. Once a player has been assigned to a team and the FV registration fee paid, no refund requests will be accepted.
10. Members agree to pay any fines that may imposed by the FV for player and parents misconduct on and off the field of play.
11. To communicate openly with the Committee of Management and staff of the Doncaster Rovers Soccer Club Inc. if any problems arise and to assist in their resolution.
12. Allocation of players to teams will be at the discretion of the Club. Placement depends upon meeting the selection criteria and team availability.
13. Members agree to complete the COVID-19 declaration prior to commencing training and submit to temperature checks if requested, practice of COVID-19 safe behaviours is mandatory at all times.
14. Coaching Fees may apply in some Junior or MiniRoos teams.
15. The Club reserves the right to suspend or expel any player or member for failing to abide by the rules, regulations and codes of behaviour.

Club Membership Special Conditions

Members of the Club or a registered participant are required to abide by the:

1. Doncaster Rovers Soccer Club Constitution;
2. Laws of the Game;
3. Statutes and Regulations and those of the By-Laws expressed to apply to or in relation to Members;
4. Statutes and Regulations and the constitutions and by-laws of FFA and FV as enforced from time to time; the FV Codes of Behaviour within the FV Rules of Competition, as amended from time to time; and
5. FFA Code of Conduct, and Member Protection Policy as amended from time to time.
